Once your HRA runs out, you must pay out-of-pocket. Any money left rolls over to the next year, but if you leave the company, you forfeit your account.
What is the overall <u>deductible</u> ?	In- <u>Network</u> : EE Only (EO) \$1,000; EE+ Family (EE+ FAM): Individual (IND) \$1,000/ Family (FAM) \$2,000. Out-of-Network: EO \$2,000; EE+ FAM: IND \$2,000/ FAM \$4,000.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. You will pay the most if you use an <u>out-of-network provider</u> , and you might receive a bill from a <u>provider</u> for the difference between the <u>provider's</u> charge and what your <u>plan</u> pays (<u>balance billing</u>). Be aware, your <u>network provider</u> might use an <u>out-of-network provider</u> for some services (such as lab work). Check with your <u>provider</u> before you get services.

Does this plan provide Minimum Essential Coverage? Yes.

Minimum Essential Coverage generally includes plans, health insurance available through the Marketplace or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage. If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.

Does this plan meet Minimum Value Standards? Yes.
